The Zambia Daily Mail Limited now invites tenders for the supply and delivery of One Thousand (1000) metric tons of Newsprint. This tender is issued under Open International Bidding Method of procurement as prescribed under The Public Procurement Act No. 12 of 2008 and The Public Procurement Regulations, SI No. 63 of 2011.

The tender will have the following margins of preference applied in accordance with The Citizen Economic Empowerment (preferential Procurement) Act No. 36 of 2011:-

- a) For citizen influenced company – 4%
- b) For citizen empowered company – 8%
- c) For citizen owned Company – 12%

However, interested local suppliers are encouraged to enter into joint ventures with foreign suppliers to enhance their participation.
